

# Terms and Conditions: "Transformers Necklace Raffle"

## 1. ORGANIZER

The Commission for the Promotion of Peru for Export and Tourism - PROMPERÚ, hereinafter referred to as **PROMPERÚ**, located at Calle Uno Oeste N° 050, Piso 13, Edificio MINCETUR, district of San Isidro, has organized the activity called "**Transformers Raffle on peru.travel portal**", hereinafter referred to as the "**RAFFLE**."

## 2. PURPOSE, MECHANISM, AND RESTRICTIONS OF THE RAFFLE

### 2.1 Purpose

The purpose of the RAFFLE is:

- 2.1.1. To increase the database of potential visitors from the US market.
- 2.1.2. To interact with visitors who arrive at our promotional landing page for the movie Transformers Rise of The Beasts.

## 3. RAFFLE DYNAMICS

The RAFFLE will take place exclusively on the Transformers landing page hosted on the peru.travel portal. To enter the RAFFLE, participants must comply with each of the following steps:

### 3.1 RAFFLE ON TRANSFORMERS LANDING PAGE

(<https://www.peru.travel/transformers/en/>)

- a) The contest is open only to citizens and residents of the United States.
- b) PROMPERÚ will conduct a raffle among the visitors of the page <https://www.peru.travel/transformers/en/>, who must enter their information in the registration form.
- c) The RAFFLE starts on **July 5, 2023**.
- d) To participate, the contestant must have read and accepted the Terms and Conditions.
- e) Participants who have filled out all the fields of the form (first name, last name, age, city, state of residence, address, nationality, identification document, phone number, and email address) will be entered into the raffle.
- f) One (01) Transformers necklace made of Peruvian 950 silver will be raffled.
- g) Users can participate in the RAFFLE until July 31, 2023.
- h) Any user who does not fulfill the aforementioned steps will be automatically disqualified from the raffle.
- i) The result of the RAFFLE will be published on the page <https://www.peru.travel/transformers/en/> on August 2, 2023.

- j) The winner will be contacted via the email they provided in the form to coordinate the prize delivery.
- k) If PROMPERÚ does not receive a response from the WINNER of the contest within the specified period as established in these Terms and Conditions, their selection will be void, and PROMPERÚ will conduct a new raffle among all contestants who have registered their information in the form.

### **3.4 RAFFLE restrictions**

- a) Only one registration per participant will be counted for the raffle.
- b) The raffle is valid only for citizens and residents with a legal address in the United States.

## **4. PRIZES**

PROMPERÚ will give away one Transformers necklace made of Peruvian 950 silver with the Autobots logo.

## **5. PARTICIPANTS**

5.1 Natural persons, of legal age, who are either US citizens or residents and meet the requirements mentioned in section 3 of this document.

5.2 The following are prohibited from participating in the RAFFLE:

- a) Non-resident citizens of the United States.
- b) Citizens who do not have a legal address in the United States.
- c) Citizens with fake documentation and/or illegal immigration status.

## **6. PROCEDURE AND FINAL SELECTION OF WINNERS**

6.1 The final selection of the winner will be made randomly from all participants who have provided their information in the registration form.

6.2 By accepting the Terms and Conditions of the RAFFLE, the winner agrees that their registered data may be used to receive promotional information from PROMPERÚ.

6.2 PROMPERÚ will conduct the RAFFLE, resulting in the random selection of one (01) WINNER, who must meet all the requirements in item 3.

6.3 The prize will be delivered after the winner is announced through the page <https://www.peru.travel/transformers/en/> and upon coordination via telephone and/or email with the Commercial Offices (OCEX) of PROMPERÚ in the United States.

6.4 PROMPERÚ will be responsible for the prize delivery and shipment, assuming the costs associated with them.

## **7. GENERAL PROVISIONS**

7.1 It will be understood, without admitting proof to the contrary, that all participants in the RAFFLE have read, understood, and unconditionally accepted these terms and conditions,

and therefore have no right to make any claims, complaints, denunciations, or actions of any kind against PROMPERÚ.

**7.2** PROMPERÚ expressly reserves the right to verify the identity of each of the winners and ensure compliance with these terms and conditions.

**7.3** PROMPERÚ reserves the right to initiate legal actions if any irregularities are detected during or after the RAFFLE as responsibility of the participant and/or winner.

**7.4** PROMPERÚ reserves the right to modify these terms and conditions if necessary for the proper development of the RAFFLE.

**7.5** PROMPERÚ shall not be liable in any way for any interruption, disconnection, deficiency, transmission failure, technical difficulties, or any similar situation that may hinder or impede participants' access and/or navigation on the Internet, social networks, or prevent the receipt of comments, including server deficiency, computer equipment used by participants, or any other similar situation.

**7.7** PROMPERÚ reserves the right to suspend the present RAFFLE for justified reasons.
